

On 24 November 2011, the Committee of Ministers approved the Programme for the biennium 2012-2013 and the Budget for the first financial year, as well as the Budget for the second financial year on a provisional basis.

Pursuant to the Financial Regulations of the Council of Europe, on 21 November 2012 the Committee of Ministers approved the Budget for the second year of the biennium adjusted on the basis of a 2% inflation rate and including operational reinforcements for some €500 000.

In January of 2010, the Secretary General of the Council of Europe initiated an in-depth reform of the Organisation, aimed at revitalising it and making it a leading, innovative and more flexible actor in shaping the common future of 800 million Europeans.

The adoption of the first biennial programme and budget is a milestone for the Council of Europe and sets the basis for better work in an ever changing world.
