### **Background**

The effectiveness of the national anti-corruption policy needs to be reviewed and analysed to learn lessons from the past and make progress in the future. NGOs and private sector acquired a valuable experience in basically every sector of governance and know well the specificities of various types of corruption practices. The implication of civil society organisations and private sector in the elaboration, implementation and monitoring of the national anti-corruption policy is critical to ensure its success and sustainability.

Important changes in the strategic, legislative and institutional frameworks are currently being prepared and it is expected to:

- define a new mechanism for coordination, monitoring, reporting and update of the national anti-corruption strategy;
- adopt a new detailed action plan for the implementation of the strategy;
- enhance specialisation in detection, investigation and prosecution of corruption offences;
- have the draft laws of the "anti-corruption package" adopted in the 2<sup>nd</sup> reading in Parliament;

Moreover civil society organisations could contribute to enhance compliance with GRECO recommendations and relevant international anti-corruption standards.

### **Purpose**

The objectives of the Round table are the following:

- To contribute to strengthening the role of the civil society and private sector in the national anti-corruption efforts;
- To review the effectiveness of the national anti-corruption strategy and action plan by civil society organisations; to raise awareness on proposed reforms; contribute to enhancing compliance with GRECO recommendations as well as international and European standards.
